In a day when civility and humility are desperately needed in public discourse, three congregations from Lexington, Massachusetts – Grace Chapel, Temple Isaiah, and St. Brigid's Roman Catholic Church – are joining together to model a new approach to discussing the complex and often contentious issues surrounding religion and politics.

The question that will guide the evening's discussion is "How do people of faith address and respond to the issue of religion and politics in today's internationalized, globalized world?" We want to discuss questions which touch on both the domestic and international dimensions of this subject, including church-state relations, inter-religious relations and dialogue, the challenge of religion and world affairs since 9/11, the crucible of the Middle East, religious liberty, and more.

We have gathered an expert panel which represents different religious traditions and different political persuasions to help our three congregations gain a deeper and more practical understanding of these subjects.

The event will be from 7:00 – 9:00 p.m. on Thursday night, March 31, 2011 and will take place in the auditorium of Grace Chapel, 59 Worthen Road, Lexington, Massachusetts. We look forward to attendees from the three congregations and the community-at-large, as we explore these important issues together.
